This Deed of Trust made and declared at Muzaffarnagar on this 18th January, 2008 by **AKASH KUMAR** S/O Shri Randhir Singh r/o 442, Kambalwala Bag - New Mandi Distt. - Muzaffarnagar (hereinafter called the Founder of Trust)

WHERE AS the founder of the Trust desires to create a Trust for the purpose of imparting the education, health, agriculture, social care and welfare of the children in all fields and allied services and to serve the purposes and objects hereinafter mentioned.

AND WHERE AS Founder of Trust establishes the trust with nucleus contribution of Rs. 51,000/- (Rupees fifty one thousand only) in cash as "Trust Property".

NOW THIS DEED OF TRUST WITNESSES AS FOLLOWS:

1. The name of the Trust shall be "EKTA RURAL RESEARCH INTRODUCTION FOR KEEN ACTIVITIES FOUNDATION AND CHERATABLE TRUST". Name of trust shall shortly be known as "ERRIKA"
2. The office of the Trust shall be situated at Meerapur Road – Jansath Distt. Muzaffarnagar (U.P.) and the address may be changed as and when found necessary by the Trustees.
3. The area of operation of the trust shall be whole of Union Of India and such other places as decided by majority of the trustees.
4. Trust shall be revocable at the instance of Founder Of Trust.
5. The benefits of the trust shall be open to all irrespective of caste, creed or religion.
6. The objects of the Trust shall be any or all of the following:
 - A. Advancement and propagation of education and learning including establishment, maintenance and support of schools, colleges and other educational Institutions.

- B. To make provisions to advance the cause of and impart nursery, primary, secondary, hire, commercial, industrial, technical, physical and all or any other type or kind of education.
- C. To establish, maintain, take over management, administer or run any institution, colleges engaged in the imparting of education to students up to any level i.e. may be found necessary and/or desirable.
- D. To generally impart education to the children and for the purpose to do all acts that may be necessary.
- E. To establish, run, manage, administer any institution, colleges or schools to train persons to be teachers who will impart to education to children and/or students in schools, colleges and other similar institutions.
- F. To promote the adult education.
- G. To hold, arrange and organize meetings, lectures, talks, discussions, seminars, symposia, conferences, competitions,

research and study visits, tours, excursion, exhibitions, debates, cinema, audio-visual programs, the artistic performances and other cultural activities, sports and games.

- H. Establishment, maintenance and support of libraries, museums and reading rooms and distribution of books etc., for advancement of education and knowledge in general.
- I. To provide and meet all expenses of the school and other educational institutions.
- J. Advancement and propagation of education and learning including establishment, maintenance and support of Schools, Colleges, Pathshalas and other educational institutions, auditorium, professorship, lectureship, scholarship and prizes etc.
- K. Advancement of any other object of general public utility and relief like conducting seminars on educational advancement, providing necessary assistance natural calamities and such other assistance as may be required from time to time.
- L. To render assistance to mentally retarded, crippled, and other physically handicapped children both directly and through institutions engaged in helping their rehabilitation through appropriate therapy, education, vocational training and other programs.
- M. To render assistance to orphan, indigent and other less-privileged children for their subsistence, shelter, education and medical care and to establish social welfare institutions engaged in promoting these objects.
- N. To render assistance to aged and indigent men and women for treatment and medical care that they can not otherwise afford.
- O. To found and maintain hospitals, medical investigation and research establishment or institutions in India for affording facilities of medical relief to the poor, the sick and the suffering.
- P. To carry on the business of growing, multiplication, development, breeding processing, of foundation seeds, parent seeds, certified seeds, commercial seeds and seller, purchase, distributors, commission and forwarding agents and with a view to raise vegetable plants, crops fruits, flower seeds, trees, shrubs, bulbs, of all kinds and varieties and kinds to process treat, refine and market seeds.

- Q. to carry on the research , breeding, and foundation multiplication program of seeds of all kind for the purposes of rural agriculture development.
- R. To provide the hybrids on royalty basis to the private agriculture sector.
- S. To carry on the business of consultants in all the field of agriculture, horticulture, tissue culture and allied field.

7. TRUSTEES :

A. There shall be a Board of Trust. The first Board of Trust shall be have following Tustees :

- (a) Shri Akash Kumae s/o Sh. Randhir Singh, aged about 40 years, r/o 442, Kambalwala Bag, Muzaffarnagar.
- (b) Shri N. Ramchandra s/o Sh. Narayanappa, aged about 40 years r/o Vill Ajjapana Halli P.O. Doda Valagamadi , Taluka - Bangarpet , Distt. Kolar (Karnataka).
- (c) Smt. Bandna Gupta d/o Sh. Lekh Raj Gupta, aged about 37 years, r/o Vill. & P.O. - Sujapur Tira, Distt - Hamirpur (H.P.)
- (d) Smt. Nabceela Khatun w/o Shri Ashim Ahmad Khan aged about 27 years, r/o Plot No - 63 , Phase - 1 Kamlapuri Colony , opp.1 B P Petrol Bunk , Hyderabad - 73
- (e) Shri Dr. Devi Dayal Gupta s/o Sh. Mitthan Lal aged about 62 years r/o Krishnaspuri Distt. - Muzaffarnagar.
- (f) Shri Hari Bhagwan Saxena s/o Sh. Rai Bahadur aged about 64 years, r/o Village & P.O. - Rajpura Distt. - Badaun (U.P.)
- (g) Shri Suresh Kumar Gupta s/o Sh. Om Prakash aged about 59 years, r/o 793, South Bhopa Road - Sanjay Marg, Muzaffarnagar

B. Shri AKASH KUMAR, founder of trust, shall be the Chief Managing Trustee. All trustees shall hold office for life or till voluntary retirement or inability to be a trustee. In his lifetime Chief Managing

Trustee may withdraw himself appointing a new Chief Managing Trustee with full and final powers like himself. Such appointment shall not be questioned any where.

- C. The Chief Managing Trustees shall power and discretion co-opt any person/or persons who may be helpful in achieving the objects of the Trust as a Trustee. Terms and duration of Trustee appointed in future may be settled by Board Of Trust
- D. After death of Founder Of Trust, the remaing trustees shall appoint a new Chief Managing Trustees among Board.
- E. The maximum number of Trustees shall be 21 (Twenty one) and minimum number shall be 7 (Seven).
- F. A Trustee shall cease to hold office of Trust on the Trustee becoming insane or lunatic or Bank crept or by 3/4 majority of Board Of Trust on different reasons.

8. MANAGEMENT:

- a. The Management, control of the property and affairs of the Trust aforesaid shall be vested in the Trustees with full powers and authority to purchase or hold any land or construct any building for the object of the Trust, to hold any funds or other properties or investment at any time, subject to the Trust of these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the Management and administration of the Trust and as they deem fit and to alter or vary the same from time to time and to make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and intents of these presents.
- b. The Trustees shall meet as often as possible but not less than two times in a year for efficient management of the Trust, to consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.
- c. At all meeting of the Trustees, presence of 30 % of trustees will form quorum.
- d. At all meetings of Trustees, Chief Managing Trustee or in his absence, any other Trustee as directed by Chief Managing Trustee shall be the Chairman and all decisions of the Trustees shall be taken by majority vote, and the Chairman shall have a casting vote in case of equality of

votes. However Chief Managing Trustee as founder of the trust shall have full right accept or refuse or change or revoke any decision and to direct otherwise. Chief Managing Trustee as founder of the trust shall have right to veto any decision of trustees and his decisions shall be final and not be challenged in court.

- e. All proceedings of the meeting of the Trustees shall be recorded in a Minutes Book kept for the purpose.
- f. Trustees who fail to attend three consecutive meetings without prior intimation or information shall cease to be Trustees, unless otherwise majority of the other Trustees accord him exception on genuine and valid grounds.
- g. In case of any difference of opinion between the Trustees in any matter connected with the Trust and its administration the decision of Chief Managing Trustee shall be final and binding on all the Trustees.

9. PROPERTY OF TRUST – All kind of funds whether in kind of donation, securities, deposits, movable or immovable assets shall be deemed to be trust property.

10. POWER OF TRUSTEES

- a. To manage Trust Funds and collect and recover the interest, income and profits thereof and to pay out the expenses of collection and other outgoing, if any.
- b. The Trustees shall have all powers specifically conferred to do things as may be required for the proper conduct of the Trust and in the interest of the Trust, whenever, such powers are not specifically conferred.
- c. The Trustees shall be entitled from time to time to open, maintain and operate a Bank account or accounts in the name of the Trust or in the name of the School or Schools or Institutions at such Bank or Banks as they may from time to time decide and may at any time pay or cause to be paid any monies forming part of the Trust Fund/School Fund or organization Fund the income thereof to the credit of any such account or accounts either by way of Fixed or Current Account or any other account. Any such account shall be operated by Chief Managing Trustees and/or any two of the other Trustees as decided time to time.
- d. The Trustees shall have powers to maintain and defend all such suits and take such other steps as may be reasonable and requisite for the

preservation of the Trust Property and the protection of the title thereof in all offices or courts established under the constitution of India. Chief Managing Trustee or any other Trustees or other authorized person or persons shall represent the trust in all such proceedings.

- e. If at any time it is found necessary to sell/ dispose off any immovable property of trust by majority of trustees subject to the power of Chief Managing Trustee as mentioned in clause (d) of para 8. In case of sale, Chief Managing Trustee or any other trustee as directed by resolution shall right to execute and do all such deeds and acts for the purpose of carrying such sales. Every amount accruing from any sale shall be deemed to be part of the Trust property and shall be applied accordingly.
- f. Trust may hold the any immovable property either free hold or lease basis. it may lease out any property to any person, trust, school, institution etc.
- g. The Trustees may at any time receive voluntary contributions from any person or persons by donation, legacy, gift, annual or monthly subscription for the benefit of the Trust. The Trustees shall apply such contribution in accordance with the objects of the Trust.
- h. Proper accounts showing all receipts and disbursements made on account of the Trust hereby constituted shall be kept by the Trustees who shall prepare Receipts and Payment Account, Income and Expenditure Account and Balance-Sheet as on 31st March every year and shall be duly audited by a qualified Chartered Accountant.
- i. The Trustees may from time to time appoint any Accountant, Clerk and other officials and employees as the Trustees may deem expedient, and fix and pay their remuneration out of the Trust Fund or the income thereof.
- j. The Trustees shall have power to raise or borrow for the purposes of Trust from time to time in the name of the Trust or otherwise on behalf of the Trust such sums of money as they may from time to time deem expedient either on the mortgage of the whole or any part of the property of the Trust, or by bonds, debentures, deposit receipts, promissory notes, with or without security or in such other manner as they may consider proper.
